Audit Findings

Audit Narrative

Life Rebuilders Midwest Challenge is a Christian based organization that provides transitional housing for Men and Women in the Minneapolis Minnesota Metropolitan area. Genesis House 1 and Genesis House 2 is a halfway house that provides work release programming in a community confinement setting. Midwest Challenge successfully complied with a PREA Audit on May 5, 2015. This is the facility's second audit in a 3 year cycle. Prior to the on-site audit, I contacted the local police department and the local sexual violence center and received information pertaining to their response to any sexual assault that may occur at the facility. I also received electronic copies of the Pre-Audit Questionnaire, staffing plans, employee and resident handbooks, training curriculum, policies and procedures along with numerous documents relating to the upcoming audit. On April 26, 2018 I arrived at Midwest Challenge and met with the President/CEO and the PREA Coordinator. I interviewed the President and was then given a complete comprehensive tour of the facility which consists of two buildings. During the tour I observed large posters and pamphlets that provided PREA information to the residents. I also saw that all the bathroom areas of the facility were private. I also noted that the facility had cameras situated in areas that could be considered blind spots. I was able to review resident files. I then proceeded to interview all the staff members that were working at the time along with all the residents that were in-house and not out on work release. Later I interviewed residents randomly as they returned from the work release program. I also interviewed additional staff as they came on duty. In total, I interviewed 11 residents and 8 staff members and was assigned a private office to conduct these interviews. I concluded the on-site audit going over the standards with the PREA Coordinator and the Compliance Manager. I spent 7 hours on the on-site audit. I made some subsequent phone interviews with persons and organizations associated with the facility. I came away with the impression that all the staff members were highly experienced and committed to the Agencies zero tolerance policy. Midwest Challenge houses only male residents which are at the end of their court ordered sentence, are being released from prison and are eligible for work release programming. These residents are supervised by the Minnesota Department of Corrections. The facility is licensed and inspected by the Minnesota Department of Corrections and is obligated to be in compliance with Minnesota Chapter 2920, Rules for Adult Community Confinement Facilities. These rules enhance the facilities efforts toward compliance with the PREA Standards by providing guidelines for staffing ratios, employee background checks and disciplinary processes, residential programming and disciplinary processes along with numerous other rules that enhance the safety and security of the facility.

Facility Characteristics

Midwest Challenge is community confinement facility that is located in a residential area in South Minneapolis. Staff members are required to perform hourly status checks on all the residents. There is a Shift Supervisor on duty 24/7 and Program Directors and Managers supplement security coverage. On weekends the facility runs overlap shifts along with flex shifts. The facility consists of two 3 story houses that have been renovated to become halfway houses. Genesis House 1 consists of offices and residential housing. Genesis House 2 is adjacent to the other house with only a narrow driveway separating the 2 houses. Genesis House 1 first floor has a main office that is staffed 24/7 along with 2 other staff offices. This floor has a six person bedroom next to the main office and 1 private bathroom with a shower. There is a lobby area and a meeting room. The first floor also has a dining room and a kitchen that has 1 full time

cook. The second floor of this house has 1 one person bedroom, 2 two person bedrooms along with a private bathroom with shower and a commons area. The third floor of the building has 2 two person bedrooms and a private bathroom with shower. The basement of this building has a laundry room. In between the two houses there is a garage that residents may use as a recreation room. Genesis House 2 has a dining area, a meeting room and 1 three person bedroom on the first floor. The second floor has 2 one person bedrooms, 2 two person bedrooms and a private bathroom/shower. The basement of this house has a laundry room and a private bathroom. There were 23 residents house in the facility on the day of the on-site audit.

Midwest Challenge has a PREA Policy that meets all the requirements of this standard. The policy includes definitions, procedures, responsibilities and an overall outline of the agencies commitment towards zero tolerance of sexual abuse and sexual harassment. Each PREA Standard is addressed in the policy giving employees guidance on how to prevent, detect and respond to any incident or allegation of sexual misconduct. The PREA Coordinator is the Vice President of Operations. The coordinator is a well-organized and experienced corrections professional dedicated to the facility's zero tolerance policy. Interviews with the President of the agency and the coordinator confirmed that the coordinator has ample time to dedicate to achieve compliance with the standards.

The facility has a well-defined staffing plan that considers all aspects of this standard. The plan provides for required and emergency staffing. The staffing plan is never compromised; staff members must remain on duty until relieved. The staffing plan is reviewed monthly and these reviews are documented. PREA concerns are considered during the reviews, including incidents or allegations of sexual misconduct. The agency follows MN Rule 2920.3700 in regards to staffing ratios. Interviews with the President and PREA Coordinator indicated that they always adhere to the staffing plan.

Midwest Challenge does not perform any strip searches or body cavity searches on any resident. Pat searches are rarely performed and only performed by same gender staff members. The facility houses only males. All bathrooms in the facility are private. There are no cameras in any bathroom or bedroom areas. The facility has a knock and announces policy and procedure to alert residents when a female staff member is entering the bedroom areas. Interviews with residents confirmed that they are never unclothed in front of female staff and that female staff announces themselves but also stated that it is rare that female staff enter the bedroom areas at all. Interviews with staff members indicated that they knew the correct procedure for housing transgender or intersex residents but also stated that they have not housed any persons meeting the definition for transgender or intersex within the last audit period.
